- D. Written permission from Manistee County Habitat for Humanity for any alterations.
- E. The Renter is obliged to return the equipment in good condition.
- F. Renter agrees to not alter the property in any way and will contact Manistee County Habitat for Humanity for any repairs or alterations required. An addendum will be written to document the alteration.

V. INDEMNIFICATION

The Renter indemnifies Manistee County Habitat for Humanity and the Equipment free and harmless from any liabilities like accidents, loss of equipment, injury or death of a person/s.

VI. GOVERNING LAW

This Agreement shall be governed under the laws of the State of Michigan in the County of Manistee.

VI. SIGNATURE
